**As per By-law No. 18/2014:**

2.1 No person shall own, possess, harbor or keep any dog within the Municipality unless a tag has been issued for the dog by the Municipality in accordance with the provisions of this By-law.

2.8 No person shall keep or permit to be kept:

2.8.1 More than three (3) dogs within or about any single detached dwelling; or;

2.8.2 More than two (2) dogs within or about any dwelling unit for properties with two (2) or more dwelling units regardless of whether that person is the owner of the dogs, save and accept properties containing kennel licenses, approved business and veterinary offices.
